VI. PUBLIC COMMENTS:

A. Mr. Joseph Dino (no address given) approached Council
concerning the following:

1. 701 Water Alley – Owned by Shirley Ewasky
and Mickey Wagner

Mr. Dino informed Council that about a year ago
Mr. Wagner and Ms. Ewasky tore down a fence
that divided the property line and built a building
and swimming pool on someone else's property.
The property owner insisted that they move it,
And they did. They filled in the storm sewer, had
a big catch basin, put in a cement slab, built a
building, and ran utilities to it. The storm sewer
has flooded several times in the past and did
thousands of dollars worth of damage on Park
Avenue.

Mr. Dino asked who will be responsible when
it floods, why Mr. Wagner could put up a build-
ing without a building permit, why he was allowed
to build on Borough property, and why it is taking

so long for something to be done.

2. Central Avenue – Stinks from the water company

In reference to Item 1, Mr. Caruso asked Mr. Treschow to look at this to see if it's on Borough property. He also asked Mr. Hazlett to check to see if a building permit was ever issued.

- B. Pam Jox (no address given) also complained about South Central Avenue. She showed Council a coil spring from her vehicle that she had to replace at a cost of approximately \$600.00 because of the gas company tearing up the road and not repairing it.

Discussion was held.

Mr. Hazlett stated that he has called Columbia Gas several times and left messages, but no one has returned his calls. He has also contacted PennDOT, and they assured him they would talk to Columbia Gas.

Mrs. Popp advised Mr. Hazlett to call the PUC (Public Utility Commission) tomorrow and file a formal complaint with them about the condition of the road. She also suggested that he advise Senator Barry Stout of what has transpired.

The Mayor suggested (since nothing has worked) that a group of citizens should demonstrate and block South Central Avenue (on a Saturday when school is not in session).

Mrs. Popp advised Ms. Jox be sure to contact the news media for coverage of the story if they decide to proceed in that direction.

Further discussion was held pertaining to this ongoing problem, including other suggestions for possible resolution.
