F. Approval of Manager's Report

Mr. Williams moved to approve the Manager's Report of September 8, 2009.

Mrs. Popp seconded the motion.

G. Act 537 Revision – Canonsburg-Houston Joint Authority

Mr. Hazlett read aloud a letter he wrote to Council in reference to this matter.

NOTE: A copy of the letter and the Resolution are attached to these minutes.

Discussion was held pertaining to the urgency of this matter due to the fact that the Act 537 Revision must be approved by DEP before application for a two-million dollar grant can be made, and the deadline is rapidly approaching. If Council does not approve this Resolution tonight, they will have to wait a year to apply for the grant, as the state needs 30 days to approve the Act 537 Plan Revision. Mr. Hazlett stated that this cannot be held over to October because the grant application must be submitted in November.

Mrs. Popp felt that Council should be given more time to review this and obtain more information in order to make an educated decision.

Mr. Michael Alterio, Chairman of the Canonsburg-Houston Joint Authority, explained the situation to Council. He also

informed Council that the Act 537 was sent to the Planning Commission (at the Borough Building) on June 24, 2009.

Mr. Alterio reviewed what has transpired and explained how the Authority did not get its share of the Optimization money because the Act 537 Plan was not approved.

Mr. Alterio explained that an Act 537 Plan is a planning document that outlines the growth in an area for a twenty-year period to determine the sewage needs in the area serving. It is only a planning document; no design has been done and no bonds have been taken out. The schedule in the CHJA Plan calls for a design to be started next year, and it takes one year to complete the design. Once the design is completed and approved by the Department of Environmental Protection, the Authority will set the available capacity remaining at the plant and determine when the project should be built. If growth is slow, the project will be delayed until such time as the capacity is required.

Mr. Alterio also explained that a month is needed for the Department of Environmental Protection to approve the plan.

Mr. Sharkady felt that a representative of CHJA should be at every Council meeting.

Mr. Alterio also felt that someone from Council should attend the Authority meetings.

Further discussion was held.

Mr. Alterio suggested that perhaps Council could study the Plan and then hold a special meeting, as this matter cannot wait until October

Mr. Hazlett mentioned that early this year the Sewer Authority had a meeting at Southpointe to explain this. Also, Mr. Zollinger has reviewed this and approved it.

Mr. Russo moved to approve the revised Act 537 Plan Resolution.

- A. Mr. Joseph Dino (no address given) stated that he was
present to complain about the wall in the alley. He said

that after the survey was done on Fountain, the wall was found to clearly be in the alley. Mr. Dino asked if the wall, which is in front of his two garages, is going to be moved. He also questioned whether his property will be taken when the alley is widened and if the people who infringed on the Borough property will be allowed to keep the wall of the shanty they built over the storm sewer.

Attorney Derrico stated that he has had extensive and ongoing discussions with Mr. Dino's attorney and Ms. Ewaskey's attorney and felt that this should not be discussed at a public meeting.

Mr. John Dino, who also owns property in the same area, added his input and expressed his concerns. He stated that he wants his 20 ft. of roadway.

Ms. Jacqueline Duke, of 410 Peco Street, stated that the only way to get to her house is through Fountain Alley. She informed Council that when the police came a few months ago because of the dispute between the Dino and Ewaskey families, Shirley Ewaskey plainly stated that she got permission from the Borough to build on that land. Ms. Duke stated Ms. Ewaskey totally remodeled the land; she had a sewer dug up, put in a pipe, threw in a bunch of dirt, tore out a bunch of Ms. Duke's trees, and destroyed other trees without ever asking Ms. Duke or her ex-husband for permission. Ms. Duke asked if what Ms. Ewaskey said was true.

Mr. Hazlett will research to see if a building permit was ever issued for 701 Fountain Street.

Ms. Duke also asked if it is true that Mickey Wagner and Ms. Ewaskey are trying to obtain permission to purchase the property in question from the Borough. If this happens, Ms. Duke will be landlocked.

In addition, Ms. Duke is concerned because she has two little girls running around in her yard, Ms. Ewaskey calls the

police every ten minutes, and her bad language is offensive. Since the new survey was completed, Ms. Duke is not sure exactly where her property line is.

Mr. Treschow asked Ms. Duke to give him her name, address, and telephone number, and he will have one of his people contact her to show her where her property line is.

- B. Terrance Serbak, of 330 Euclid Avenue, who is a Scout with Troop Number 1333, asked questions of Council in order to earn a merit badge for Citizenship and Community.
- C. Ms. Serbak (Terrance's mother) informed Council that she and her family are actually considering moving from 330 Euclid Avenue (where they have lived for 18 years) because they no longer feel safe due to all the crime, vandalism and drugs in the area.
