Discussion was held pertaining to College Street, and Mr. Hazlett assured them the street will be open.

Ms. Kusturiss reported on the plans for the opening ceremony to be held at 6:00 P.M. Friday.

- B. Ms. Rebecca O'Donnell, of 206 East College Street, Telephone Number 724-745-5245, and Lisa Cregut, of 210 East College Street, Telephone Number 724-746-5848, approached Council as representatives of a group of residents who want to petition Council and Zoning to consider an ordinance that would limit the number of halfway, three-quarter, sober living, recovery homes, group homes, or boarding houses that can be established and operating within each ward.

Copies of the request and copies of research and documentation from other communities who have adopted ordinances involving these same issues were passed out to each Council representative.

NOTE: No copies were provided to attach to the minutes.

Mr. Milioto informed Ms. O'Donnell and Ms. Cregut that a lot of this matter has been turned over to the Zoning Hearing Board, who will hold a meeting on September 23, 2010 pertaining to this. He also stated that there is a resolution pertaining to family, which is part of the issue they are concerned about, on tonight's agenda,

- C. Ms. Dana Snedeker, of 16 North Jefferson Avenue, Telephone Number 724-255-8319, informed Council that she has put numerous hours into calling Washington County, local Drug Enforcement Agencies, and she has put in five calls to the Detective in Canonsburg Borough regarding drug activity in and around the building where she lives, which is a block and a half away from the Borough Building.

No one returns her calls. Her landlord can't help in evicting these

people. Karen's Korner Bar, which is next door, has cleaned it up a little bit by shuffling the vagrants out who used to come in from the bar, sleep on the stairs, and urinate in the building. Now there is a tenant in her building who averages 30 to 40 people a night, in and out, doing drug deals. She said that no one seems to care.

Ms. Snedeker asked if there is an agency in the Borough to address issues such as this.

Mr. Milioto replied that the County has Washington County Drug Task Force.

Ms. Snedeker used to call them every week, but now she calls every three days, but no one returns her calls. She also is getting no response from the Detective in the Borough.

Mayor Rhome stated that neither he nor the Police Chief has received any calls on this. When someone does call in reference to this type of activity, a daily meeting is held with the Chief, Deputy Chief, Detective and the Mayor to discuss issues of this nature.

Mayor Rhome advised Ms. Snedeker that if she would like to make an appointment to see the Chief, Deputy Chief, Detective, and Mayor, they look forward to her input.

Chief Bell suggested that Ms. Snedeker call tomorrow or any time this week that she is available, and they will be happy to talk with her.

Mr. Sharkady asked if bids are needed.

Attorney Derrico replied that bids are not required for professional services.

Discussion was held pertaining to how Hayes Design Group was selected, the fact that time is of the essence, basic cost of the study, the as built drawings the Borough could not locate that Hayes Design Group had, and the issue Mr. Williams brought to Council last week pertaining to the Library not wanting to vacate its present location in the Borough Building.

This one concerns tree limbs, branches, and trunks on Smithfield Street, Vine Street, and Craighead Street. Mr. Coleman said he has asked Mr. Kazmarski to meet with Mr. Holliday tonight to write the information down. Discussion was held.

Mr. Coleman wanted to go on record that this matter is of high priority. Those trees should be cut down to protect the children

walking to and from school or buses from this hazard.

Mr. Kazmarski stated that Public Works is looking into the tree problem. They are very busy, but if needed, they will bring in a private contractor.

Mayor Rhome mentioned that for the past twenty years the Fire Department has come to Council in regard to the low hanging trees everywhere, but he was told there wasn't enough money to handle the tree problem throughout the community.

Further discussion was held.

- C. Handicapped Parking – Brought up by Mayor Rhome
Mayor Rhome said that one of the East End Council Representatives had asked him to put an extra effort on Handicapped Parking on Euclid Avenue due to many complaints. One was not posted properly, but it was taken care of this weekend.

- D. Overweight Trucks – Brought up by Mr. Milioto
Mr. Milioto stated that discussion was held last week pertaining to overweight trucks on Gladden, McEwen, and Hooks Lane. Mr. Graziani has contacted Mr. Milioto about this and wants to work with the Borough on this, even though he feels the trucks coming to his developments are not overweight.

Discussion was held pertaining to the roads not being made for such vehicles and the wear and tear on the roads.

Mr. Treschow mentioned that there is such a thing as an impact analysis, and the Borough would have the right to charge an impact fee. .

Further discussion would be needed on this matter before taking any type of action.

Mr. Williams stated that Council hasn't gotten any reports from the Library Board lately.

- C. Tax Collection Committee – Brought up by Mr. Hazlett
Mr. Hazlett reported that he represented the Borough at the Washington County Tax Collection Committee last week. They voted in favor of Keystone to collect the local (earned income) taxes for the county at a rate of 1.5%. Keystone is located in Irwin, and Mr. Hazlett felt that if we're hiring a company that's going to hire several dozen people to collect taxes for the county, the company should be located in Washington County and the people they employ should be paying taxes somewhere within the county.
