A. Parking Meters in Front of Homes – Brought up by Mr. Russo

Discussion was held pertaining to 15 parking meters that are in front of homes. Parking meters average revenue of \$235.00 per year. Removing 15 meters would cost the Borough approximately \$3,525.00 annually. These residential meters include eight on Pike Street, five on Jefferson Avenue, and two on Greenside.

IX. NEW BUSINESS:

- A. Employee Absence Due to Illness – Brought up by Mr. Hazlett

- B. Neighborhood Parking – Brought Up by Mr. Coleman

Mr. Coleman stated that the firemen and police are complaining that many delivery trucks are having trouble getting around the streets because of people parking on both sides of the street and parking close to intersections.

Mr. Hazlett has addressed this and informed Council members that they have a copy of the letter in their boxes.

Further discussion was held pertaining to overhanging trees and public safety, as well as enforcement of ordinances/rules.

Mr. Hazlett will be meeting with representatives of the Fire Department next week. In addition, he has sent memos to Code Enforcement and Zoning in reference to issuing citations for failing to have house numbers on homes.
