Mr. Bell – Question

Mr. Russo – So

Mr. Bell – Go ahead Mr. Russo

Mr. Russo – So, this is the winter ad on, am I correct? Change Order Number, from last week's discussion, change order number 10, right. I'm sorry number three. I think that was the forty thousand change order from the winter heating and tenting to lay the block

Mr. Lawrence – Actually, I think it was \$60,000.00 they were talking about

Joe Dalfonso, Solicitor – Yeah, we should probably

Mr. Russo – So, it's the next one you think?

Joe Dalfonso, Solicitor – He has the engineer's report

Mr. Russo – Ok

Mr. Lawrence – The money they are talking about is for all the changes. The trench drain, the heat trays, the change of the sanitary line, connection to the new garage, drain around the salt shed, enlarge the fuel tank pad, enlarge the wash bay concrete pad, additional hose bib, new

floor drain in the office garage, and additional doors

Mr. Russo – And this is the \$42,000, Tom?

Mr. Lawrence – Yes

Mr. Russo – Ok. So, it must be the next one that is the winter

Mr. Lawrence – Yes

Mr. Russo – Ok. So, I don't have any other questions on the \$42,421

Mr. Chandler – Ok. Mr. Bell had a question

Mr. Bell – That's what I was wanting to know and ask our solicitor this question. While we do these, I would like to have, since Mr. Lawrence has all the, I would like each one of these to be gone over so know which exactly. We've gone over these before, but we have so many bills coming in right now, what each one is for. Is that proper?

Joe Dalfonso, Solicitor – It absolutely is

Mr. Bell – I don't want to vote against something wrong

Joe Dalfonso, Solicitor – If you have questions on these, you can always table them to next month to get a better explanation. That's another reasonable alternative. You may be voting them down because you have questions that are unresolved because you need to speak with the engineer. That's just another alternative that council can take

Mr. Lawrence – I don't know if the dispute is if they did that work or if we believe they went above and beyond what the fees or charges are for. I'm not sure because I believe the work is done on the first two (2)

Mr. Russo – I think you have two (2) issues that I know we've talked about. One is the winter work which is the next one

Mr. Lawrence – I'm not sure it's the winter work Rich I think that's just

Joe Dalfonso, Solicitor – You have the

Mr. Lawrence – I do

Mr. Russo – So, the winter work is one of them. I think the other question we've had is which is not these bills is KLH. 'S actual expenses. Keep in mind you're voting against the contractor here, not KLH. Those bills are in your warrant list. That's those bills are. If you want to question KLH, you have to stop the motion on the warrant list. Am I right Denise?

Denise Lesnock, Borough Manager – Correct

Mr. Russo - So these are not KLH expenses. These are the contract. Now, the one for the winter, we did talk about and, you know, should there be a charge for covering the block and doing work in the winter?

Mr. Bell – Right

Mr. Lawrence - Time and there's not a bill presented for that yet, Rich. All these other bills down through here are for work completed so

Mr. Russo – Ok

Mr. Lawrence – So, the way I read what's described on here compared to what's on here.

Denise Lesnock, Borough Manager - Work completed to date

Mr. Russo - What was the 68? Do you have a have the detail on the 68?

Joe Dalfonso, Solicitor - That's number three.

Mr. Lawrence - It just says for work completed to date, so if they're going to submit that bill for the other.

Mr. Russo - Where? Where did you? Get that detail on the 42?

Mr. Lawrence – On 42? It was in a complete.

Joe Dalfonso, Solicitor - Yeah, this is the actual change order explanation so.

Mr. Russo - Do you have the one for the 68 there also?

Joe Dalfonso, Solicitor - I don't

Denise Lesnock, Borough Manager - The 68 isn't a change order, it's an actual work to date invoice

Joe Dalfonso, Solicitor - That's pay application.

Mr. Russo - Ok. So, we haven't seen one for the winter work

Joe Dalfonso, Solicitor – No

Mr. Lawrence – Correct

Denise Lesnock, Borough Manager - Correct

Mr. Russo - Just as long as we're clear from it's just the finance standpoint these are

Mr. Yorke - Well, mine is a very basic statement once I don't trust you on something and you don't acknowledge me to give you a reason to trust you, I just say no, no, no, no. That's my opinion. That's all there is to it

Mr. Chandler – That's fine

Mr. Russo - Are you talking about KLH or are you talking about Spartan Construction?

Mr. Yorke - Like it's a how do you say like a trickle effect

Mr. Russo – A blanket, no

Mr. Yorke - I was saying if it trickles down, if I can't get answers from top dog that know what with and don't and I don't feel they have someone there watching the shop I got a problem with that and that's my problem, so I don't know how truthful these bills are. And that's the way I feel

Mr. Chandler – Ok

Mr. Russo - Yeah

Mr. Chandler – Yeah, that's fine

Mr. Lawrence – This isn't going to hurt KLH

Mr. Russo – It's not going to hurt KLH at all

Mr. Bell – If I can finish my comment. I agree with Mr. York, there are questions on these bills, and everybody can see that we have questions on them. And I think what it is is that some of us are wanting to make sure we don't OK things that we questioned before that we had to move forward. So, I'm ok with the way I voted, at the same time I could have voted to table if that would have been easier or better. I don't know how Mr. Yorke felt, I'm just saying, personally, tabling them makes us give us another month to look at them and come back at it next month.

Mr. Yorke - And get some explanations and. Get some explanations.

Joe Dalfonso, Solicitor - I mean. These these bills aren't going to go away just because you voted them down. You're probably going to see something again.

Mr. Bell - Well, and what I'm trying to maybe think now that we're now that we're into this. If it was possible for. Is it possible for us to rescind the other two votes and do that.

Joe Dalfonso, Solicitor - I don't think you have to. It's an outstanding bill. It's going to be back in front of council at some point, right, I think tabling it sends a message to the contractor that hey, we're not saying no, we need some more information from you from the engineer to make a better decision on what these invoices encompass, right?

Mr. Severine - Yeah, but I like to see. I mean, they just tell me to vote this way, I'm like Ed and R.T. I gotta have more information.

Mr. Russo - Well, and I, but I think to give to give us the opportunity not to be in this mess, that's a conversation for last week when Jeff is here. We voted to or we, we said, to move forward to vote on. That's when you.

Mr. Bell - Now, but now when we made after we thought about it this week and talked into it some more, you know, there's questions in my mind at least. And I think some others is just whether which ones are we totally passing. Are we passing things that we don't that we weren't happy with before that we had to leave alone because we wanted to get the project done, I don't know, I'm just. I'm just throwing that out on my own.

Joe Dalfonso, Solicitor - I mean, look, these are all for work that has been completed, right?

Your contractors, whether to the public works or the parking lot, they've done some work. If there's a question as to what work they've done

Mr. Lawrence – What work we are paying for? What was done for that amount of money?

Joe Dalfonso, Solicitor – Exactly. Then that's a legitimate question that you can go and get more information on. If that's the case, I think it sends a better message that you're tabling it for more information than as opposed to to saying no

Mr. Severine - I agree with that. I mean because like Rich said we we talked about last week, but I got presented to that take me this whole week to study and look at it.

Mr. Chandler - But I agree. But I go back to, what Mr. Russo said last week if that was the case then, then you guys have to. If that's the case, please at the at the agenda meeting, ask for that information because Jeff was here, so ask for that information so we're not here in the voting section now with questions or if there's any questions up to the voting opportunity, we can get answers to those questions. That's I mean you can you can do whatever you want to do, but I'm. I'm just saying.

Mr. Severine – Well I understand what you're saying, but it take me a little longer to just. It comes to my mind right then here I got it. I get my paper on Friday. It isn't like I've got my paper three weeks ago.

Mr. Russo – John, the question that we have now is not something that you have to think about

Mr. Severine - Yeah I do

Mr. Russo – Well wait. the question we have on the table is we need more information. That doesn't take a week to decide that you need more information so it's not fair to the contractor, number one cause it's going to take another 30 or 60 days to get them their money.

Mr. Severine – Oh well

Mr. Russo - Now KLH's bills, on the other hand, if you want to penalize or have somebody sit behind the bill and not get paid, KLH would be the one for not doing what we expect them to

do. The contractors just doing down there what KLH is directing them to do. That's all. You're holding money from the contractor. You're not doing anything to KLH. We just approved all KLH bills in the warrant list

Mr. Yorke - And to note, I did ask KLH in this particular time, that I want a detailed list sometimes of what they're doing. I want that here that's on record so that's no problem with that. From one week to the other, it's our option if we feel like changing our mind, we change our mind, that's tough. That's the way it is.

Mr. Chandler - I don't disagree with you at all, but what I'm saying is that's why we have the agenda meeting so that you have the opportunity to ask those questions and get that detailed information. That's all I'm saying.

Mr. Yorke - And if you were in the executive session, which we were, and I'm not going to discuss what went on in there. Some of the answers we got, still, to this day, doesn't. I find it hard to swallow.

Mr. Chandler - Ok, so no one came to me as president of council, said Eric I need more information and if that's the case, I've could've went and got more information

Mr. Bell – You're right

Mr. Chandler - So I so in the future if you guys need more information that wasn't presented, please come to me so I can get that detailed information and distribute it to you all.

Mr. Yorke - It would be nice if we could go to the individual. Will say such as, as if the engineer and called him and ask him something and he would get a call back and he would give us the information without going through you the third party to come back to us.

Mr. Chandler - Well, usually it works. It's easier if one person actually does that so that they don't receive multiple calls.

Mr. Yorke - So in other words, don't call him.

Mr. Chandler - I didn't say that. I'm saying

Mr. Yorke - Yeah, I'm trying to get a handle on this.

Mr. Chandler - i'm saying seven if seven people were calling our engineer, or our solicitor, right and asking them seven different questions versus give the information to me, I will go to Joe and Joe here's a list of all the information and then I can distribute it back out. It makes it much easier.

Mr. Yorke - Ok, just make a policy like that. Then anybody up for that?

Joe Dalfonso, Solicitor - Look and if anyone of you called me I say, hey, bring it up at the meeting so everybody's on the same page. That's pretty much a stock answer from me right. I don't build things though, and when you go build things that tends to cost a little bit more money.

Mr. Chandler – So, we will create a policy that says in the future, instead of everybody calling, whether it's engineer or solicitor, call me and I'll make sure I get your answers answered.

Joe Dalfonso, Solicitor - Yeah, it's up to. You guys.

Mr. Chandler – Ok. So, back to Mr. Bell, back to your original question. You need. You're saying that you need more information, correct?

Mr. Bell - I feel we do, yes

Mr. Chandler - Ok. So, we're at #6. We had the voting correct, no? We didn't vote yet.

Melissa Graff - That was just there was a first and a second for a motion. There was no roll call yet at all

Mr. Russo – On six

Melissa Graff – On item number six, correct

Mr. Bell - If I can clarify, my Mr. Russo was explaining, I think what this bill is up for vote right now is which one?

Mr. Chandler – Number 6 which is for \$46,421.83. That was a change order at public works, and I think Mr. Lawrence read off the detailed information that was

Mr. Lawrence - If anybody wants to look at that here's the

Mr. Bell – I don't want to look at it now, Tom

Mr. Lawrence – Ok

Mr. Bell - I'm just wondering if that was for the winter changes. That's not the winter changes

Denise Lesnock, Borough Manager - No

Mr. Lawrence - No, not according to the list that was presented by KLH.

Mr. Bell - Ok, that answers my question. Thank you.

Mr. Russo – Yeah, and again that's the 42,000 R.T. is all of these things at public works, right for Spartan. You know fuel Tank, Wash Bay, hose bib and it's a change order, so it's additional charges, right? That the ones four and five, I just want to go back to that real quick just so we all. So, four is a change order so that's an additional charge. Five is part of the contract cost. That's 65,000 that those guys didn't charge us extra. That's what they bid. That's what we approved. That's what we said it was going to cost. They did their work and now we're saying to Quigley, "you bid it at that price, you did it at that price, you billed us at that price, but you know what, we're not paying it. I don't think that's fair

Mr. Bell - But one of those was a change order

Mr. Russo – But four was a change order. \$4000.00 follow this. Four was the change order \$4000.00 for additional asphalt when we went over there and they had to move the concrete, you heard Jeff say it, we made the entrance bigger, they moved the sidewalk, they had to come back, do some extra asphalt, Jeff, explained that, and he explained that last week and we didn't at that point say no, but that's fine, we say no now. That was an additional amount. Five is part of their contract. A contract that we approved part. Of the bill that we already approved when we gave the job. That's not a change or it's part of their bill, and we turned that down. So that contractor, if it's me, I'm going to say wait a minute. You guys approved my contract you approve my bid. I'm sitting here with the bill for you for the stuff that I did, which you approved I do, and you're telling me, no you don't want to pay me. So, it's just an understanding guys, I'm not trying to, you know, say we're not understanding it but but in that case I don't think that's right that that contractor not get paid for with for work that he did, there wasn't anything extra. It was work we asked him to do, and we gave him a contractor there

Mr. Severine – Ok, so then on six

Mr. Russo - So just I mean and again going back, if we got issues with KLH, that's where you go as it did in executive session. You don't say to Quigley, I'm not paying you \$65,000 even though you did the work according to our specs and did it fine and the parking lots open, you know what, I'm not paying. They're going to say, why, and we're going to say, well, we really didn't know why we just said no. That's not fair guys. Come on, we're better than that

Mr. Bell - Well, I'm as I said I thought was part of that was the winter one but it's it wasn't so

Mr. Chandler - And now we're number six and #6 is a change order

Mr. Severine – It would be just like number four.

Mr. Chandler – Correct

Mr. Severine - And seven is like

Mr. Chandler - And seven was part of the contract

Mr. Severine – Part of the contract. So, six and four are change, and five and seven are part of the contract

Mr. Chandler - Correct

Mr. Russo – So, right. So, can we go back and change 5?

Joe Dalfonso, Solicitor - Yeah, you will need to do a motion for reconsideration, for number five, and then vote on it

Mr. Chandler - Ok, so let's finish six. Right now

Joe Dalfonso, Solicitor - OK. Yeah

Mr. Chandler - Ok, we are at six. So, we had a 1st and the 2nd

Mr. Severine - Number six is the change, right?

Mr. Chandler – Number six is a change order

Joe Dalfonso, Solicitor - That's change order, number three John

Mr. Chandler – Change order number three, Mr. Russo and Mr. Lawrence. Mr. Russo made the motion and Mr. Lawrence seconded the motion

Melissa Graff – Correct

Mr. Chandler - Now at this point in time, if you want to table it, you have the opportunity to do that

Joe Dalfonso, Solicitor - There would need to be a motion to table at this point

Mr. Russo – So, I can change my motion to make it a motion to table number six

Joe Dalfonso, Solicitor – Correct

Mr. Chandler – So, Mr. Russo changes his motion the motion to table number six. Is there a second?

Mr. Bell – You need me? Who second who 2nd that last one

Mr. Russo – Tommy

Mr. Bell - Tommy, does he take his back too?

Mr. Lawrence - So we are at number six now

Mr. Chandler – We're at number six

Mr. Severine - We're going to table

Mr. Chandler – Hold on

Melissa Graff – So, Councilman Russo made a motion to table number six

Mr. Chandler – Correct

Melissa Graff – No, he did not

Mr. Chandler – Mr. Lawrence and Mr. Russo made the motion

Joe Dalfonso, Solicitor - It's going to be two parts to this it's. It's going to be a motion to reconsider number five. If that's an affirmative vote and you're you take action on number five subsequently, Ok

Mr. Russo - So I'll make a motion to reconsider number five
